Exploring how Herzberg's theory specifically applies to the sports coaching context, in contrast with other motivational frameworks, would enrich the narrative.

The review effectively highlights the relevance of Herzberg's theory but could be expanded to include more recent studies specifically related to sports coaching. Additionally, a more critical evaluation of conflicting findings in the literature would strengthen the review. Identifying gaps in the current research that this study aims to fill would also be beneficial.
