"The statement 'Data collection continued until theoretical saturation was achieved' is vague. Provide more detail on how saturation was determined and the specific indicators used to conclude that saturation was reached."

"The 'Semi-Structured Interview' section mentions that an interview guide was developed. Include an appendix with the full interview guide or a summary of the key questions to provide readers with a clearer understanding of the data collection process."

"The 'Findings and Results' section provides demographic data but lacks detailed context. Consider adding a table summarizing demographic characteristics and any relevant sub-group analyses that were conducted."

Reviewer:

"In the introduction, the sentence 'Various studies have identified a range of barriers that prevent low-income individuals from participating in cancer screenings' lacks specific citations. Please integrate specific studies that have identified these barriers to strengthen the argument."

"The introduction provides a broad overview of barriers and facilitators but lacks a clear statement of the research hypothesis. Consider adding a hypothesis statement that links the literature review to the research objectives."

"In the 'Study Design and Participants' section, you mention recruiting through community centers and local clinics. Explain why these specific recruitment sites were chosen and how they contribute to the representativeness of the sample."

"Discuss how the findings of this study compare to similar studies conducted in other geographic or cultural contexts. This will help in understanding the generalizability of the results."

"Expand on the practical implications of your findings. For example, discuss how community health workers can be more effectively utilized to address the identified barriers to cancer screening."
