## 1.2 Reviewer 2

#### Reviewer:

Clarify how qualitative and quantitative phases were integrated—was it through sequential explanatory design merging at interpretation, or was there iterative feedback between phases?

Justify excluding non-sport-related psychiatric cases, as this could bias the sample toward healthier participants.

Include references to validation studies specifically in Norwegian or Scandinavian athletic populations to ensure contextual appropriateness.

Consider including minimal clinically important difference (MCID) thresholds for EDE-Q and BI-AAQ to interpret the practical significance of observed changes.

Clarify whether these  $R^2$  values are from separate models or nested models, as interpretation differs.

Expand on potential mechanisms beyond perfectionism and deselection fear—e.g., how coach-athlete relationship quality may moderate this pathway.
