Reviewer:

The introductory paragraph could benefit from clearer articulation of the study's specific scope. While global and national statistics are essential, a more concise summary followed by an explicit transition to suicidal ideation and spiritual well-being would improve the narrative flow.

While percentages are valuable, it would strengthen the academic rigor to reference specific study titles or years directly next to such statistics for reader validation.

The psychometric properties are well-discussed. Please elaborate on how cultural and linguistic adaptation was conducted in the Persian version—was back-translation used?

Pre-test assessments should logically occur before any psychoeducation begins. Please confirm whether the assessment occurred prior to content delivery and rephrase for clarity.

This interpretation should be quantified (e.g., "less than 1-point change on average") and statistically substantiated, rather than left as a subjective phrase.

Reviewer:

The novelty of the study is well-stated. However, to strengthen the rationale, please cite at least two Iranian studies that used only one of these therapies, to clearly demonstrate the lack of comparative research.

Consider adding a flow diagram of participant recruitment and attrition, in line with CONSORT guidelines, to enhance transparency.

There is an imbalance in the duration and number of sessions between the two therapies (8 sessions for CFT vs. 10 for UTT). Please explain how this was statistically or methodologically accounted for.

While the assumption of normality is addressed, please include a sentence about testing sphericity and how violations (if any) were managed (e.g., Greenhouse-Geisser correction).

You've reported "Eta Squared," but it appears to be partial eta squared ($\eta^2 p$). Please confirm and label accordingly to align with APA guidelines.

The term "stronger effect" could be quantified. Include effect size metrics (e.g., Cohen's d) for each between-group comparison.

Several sentences restate that the Unified Transdiagnostic Treatment helps "process emotions." Consider condensing overlapping explanations to sharpen the argument and reduce repetition.
