The paper mentions distributing questionnaires among teachers and educational administrators. Clarifying how respondents were selected and addressing potential biases in response rates could enhance the reliability of the results.

While SPSS and Smart PLS were used for data analysis, the manuscript could benefit from a more detailed explanation of why these particular statistical tools were chosen and how they align with the research questions.

Consider enhancing the clarity of the results section by using more visual aids such as charts or graphs, which could help in better illustrating the relationships and findings discussed.

Expand on the ethical considerations by discussing any potential biases or ethical dilemmas encountered during the research process and how they were mitigated.
