

### 1.1. Reviewer 1

"Data collection tools included researcher-constructed open-ended questions" - Please include an example of these questions in an appendix for readers to understand the scope and depth of the qualitative inquiry.

The description of the Kolmogorov-Smirnov test for checking normality is good, but it would be more informative if you could also provide the results of this test to confirm the normality assumption.

The table lists major categories, main components, and sub-components. Consider adding a brief narrative explaining how these components were derived from the data and any patterns observed during the coding process.

The statement, "A total of 92 initial codes were extracted from the interview texts," could be supported by a brief description of how these codes were refined and categorized into the final components.

The comparison of your findings with those of Seifi et al. (2024) and other researchers is very useful. Consider adding a comparative table that visually illustrates these alignments and differences.

When discussing the alignment with Jameson & O'Donnell (2015), it would be helpful to specify which elements of "Strong Command and Organization" and "Financial Resources" are particularly relevant to your study.
