#### 1.1. Reviewer 1

#### Reviewer:

"These results are consistent with the findings of Nguyen and Lee (2023)...": Strengthen the discussion by addressing potential discrepancies or limitations in the cited studies compared to your findings.

#### 1.2. Reviewer 2

#### Reviewer:

"Depressive and obsessive-compulsive disorders cause significant distress...": The authors may benefit from providing recent global statistics to quantify the impact of these disorders and strengthen the argument.

The review of dark personality traits could be expanded. Mention recent studies that have explored the impact of these traits on clinical outcomes, and include more nuanced perspectives on the dark triad components.

"Narcissism is distinct from the more negative traits of Machiavellianism and antisocial behavior...": Clarify the significance of this distinction in the context of psychological disorders. How does it specifically affect treatment or outcomes for OCD and depression?

"The Beck Depression Inventory was designed and developed by Beck...": The reliability and validity details provided are useful but could be supplemented with more information on the cultural adaptation of these tools for the Iranian context.

Provide more justification for the selection of the Dark Triad Personality Questionnaire. Were there alternatives, and why was this tool deemed the most appropriate?

The explanation of self-compassion as a protective factor is insightful. However, delve deeper into the mechanisms that might explain this relationship in OCD compared to depression.

"These differences can contribute to a better understanding of the various mechanisms...": The conclusion is clear but could be more impactful. Suggest specific practical applications or policy implications based on your findings.

End with a strong statement on future research directions. Consider mentioning the potential for interdisciplinary studies that include neurobiological or genetic factors.
