Strengthen the discussion by integrating more comparative analysis with previous studies. Highlighting similarities and differences in findings can provide deeper insights into the intervention's effectiveness and its potential applicability in broader contexts.

Address the implications of the findings for clinical practice, specifically how the training program might be adapted or integrated into existing support services for families dealing with ODD.

Elaborate on the limitations related to the study's design, particularly the lack of randomization and the potential impact of this on the results. Discuss how future research might overcome these limitations through randomized controlled trials or longitudinal studies.

Suggest avenues for future research, including exploring the long-term sustainability of the training's effects and examining its impact on other family members, such as siblings of children with ODD.
