1.1. Reviewer 1

Reviewer:

The themes "Concerns about Clothing and Hijab" and its sub-themes should be clearly distinguished. Consider separating the discussion of "Dressing Style" and "Observing Hijab" for clarity, as they address different aspects of conflict.

Findings, Sample Quotes: Ensure that all sample quotes are properly coded and referenced. For example, "Code 1, 2, 28, 30" should specify the exact participants to enhance the credibility of the findings.

Findings, Main Theme 3: The theme "Value Issues" is broad and can be divided into more specific sub-themes. Consider further breaking down "Social Reaction," "Fear of Reputation," and "Cross-Gender Interactions" to provide a more detailed analysis.

Findings, Main Theme 5: The sub-theme "Physical Punishment" includes quotes about emotional reactions to physical punishment. It would be helpful to differentiate between the physical act and the emotional impact in the analysis to provide a deeper understanding of the conflict dynamics.

For instance, explain how the lack of cultural diversity among participants might influence the generalizability of the results.
