## 1.1. Reviewer 1

Reviewer:

Methods, Cognitive Behavioral Therapy Sessions: "For Session 5: Psychological Relaxation Techniques, specify which relaxation techniques are taught and provide references to their efficacy."

Introduction, Paragraph 5: "The claim that women feel a greater need for love and belonging due to their maternal role needs a stronger theoretical or empirical basis. Please elaborate or provide references."

Methods, Study Design and Participants: "Clarify the inclusion criteria, specifically how 'no participation in other therapeutic interventions' and 'no psychiatrist visits in the past month' were verified."

Findings, Statistical Analysis: "The section on the normality assumption should report the exact p-values from the Shapiro-Wilk test for transparency."

Findings, Table 2: "Clearly explain why the follow-up results are not significant, and discuss potential reasons or implications."

Limitations & Suggestions, Paragraph 2: "When suggesting future research directions, explicitly mention the need for randomized controlled trials (RCTs) to validate the findings."

Limitations & Suggestions, Paragraph 3: "Expand on the potential moderating variables such as social support and personality traits, providing examples of how they might influence the effectiveness of CBT."

Conclusion, Paragraph 1: "Reiterate the specific statistical findings in the conclusion to emphasize the robustness of the results."
