Practical Implications: The conclusion mentions that curriculum liberalization has both positive and negative outcomes. Expand on the practical implications of these findings for policymakers and educators at Farhangian University (Conclusion, paragraph 1).

Ethical Considerations: The study involves human participants. Include a section on ethical considerations, detailing how informed consent was obtained and any measures taken to protect participant confidentiality (Methods, new paragraph).

Limitation Discussion: Discuss the limitations of using a descriptive-survey method and how these limitations might impact the study's findings. This will provide a more balanced view of the research (Conclusion, new paragraph).
