The current length of the introduction section could be more concise. A more focused introduction of approximately 1000 words would provide a clearer and more direct exposition of the study's context and objectives.

To improve clarity, please describe the measurement for each variable in a single, dedicated paragraph. This will facilitate a better understanding of the methods used and enhance the replicability of your study.

The presentation of data would benefit significantly from the use of tables. Tables can offer a more structured and accessible view of the results, aiding in the comprehension of the findings.
