"In conclusion, cultural festivals play a significant role in promoting family cohesion..." - This conclusion would benefit from a more detailed summary of key findings and their implications for future research.

"Brownett and Evans (2020) emphasized the role of community arts festivals in placemaking..." - Consider adding a definition of "placemaking" to ensure clarity for readers unfamiliar with the term.

"As Maráková et al. (2018) pointed out, visitors' motivations for attending cultural events vary..." - Discuss how different motivational factors might influence the extent to which family cohesion is affected by festival attendance.
