Including a broader range of sources, particularly from different cultural contexts, could offer a more global perspective on the issue

Given the library-based research approach, it would be beneficial to detail the criteria for selecting sources, including databases searched, keywords used, and inclusion/exclusion criteria. This would enhance the replicability and credibility of the review.

Proofreading for grammatical errors and ensuring consistency in terminology related to cyberspace and internet use would improve the readability of the paper.

While the paper touches upon critical issues, a discussion on the ethical considerations of research in this area, including the protection of children's data and privacy, would be pertinent.

The conclusion could be strengthened by outlining specific areas for future research, such as longitudinal studies on the effects of cyberspace exposure or the effectiveness of different intervention strategies.
