The article frequently cites statistics (e.g., the 42% increase in IPV incidents). Including more detailed analyses, such as demographic breakdowns or longitudinal trends, could provide a more nuanced understanding of the problem.

While numerous studies are referenced, a critical analysis of their methodologies, potential biases, and the contexts of their findings could strengthen the article's credibility and offer a more comprehensive understanding of the research landscape.

Highlighting specific evidence-based practices for IPV/DV advocacy and discussing the empirical support for these interventions could make the recommendations more actionable and grounded in research.

Reviewer:

The document could benefit from an explicit section discussing the limitations of current research on IPV/DV, especially regarding the underrepresentation of marginalized communities and how this affects the generalizability of findings.

While the article touches on issues related to gender and sexual minorities, a more detailed exploration of intersectionality—considering race, class, disability, etc.—in the context of IPV/DV could provide deeper insights into the complexities of advocacy and support.

Introducing and critiquing various theoretical frameworks or models related to IPV/DV advocacy (beyond disempowerment theory) could offer a richer academic foundation and suggest avenues for future research and practice.
