## 1.1. Reviewer 1

While thematic analysis is described, the process of moving from codes to themes needs to be more transparent. Detail the decision-making process, possibly including a flowchart or table, which shows how initial codes were grouped into themes.

Increase the number of direct quotes from participants in the results section to enrich the narrative and provide evidence for the themes identified. This would also enhance the authenticity and depth of the qualitative analysis.

Explore and discuss any contradictory or unique cases that do not fit the general patterns identified in the thematic analysis. Addressing these can provide a more nuanced understanding of the data.
