1.1. Reviewer 1

Reviewer:

The citation "Studies in different societies show that internet use has a positive and meaningful impact..." lacks specificity regarding the referenced studies. Adding examples or a brief description of the studies would strengthen this claim.

In Table 1, the term "No." in the first column could be replaced with "Category ID" or "Factor Number" for clarity. Additionally, providing examples for each factor would make the table more informative.

1.2. Reviewer 2

The sentence, "Social integration is both a process and a goal," in the introduction section is pivotal. However, its meaning could be clarified by specifying how these dual aspects influence policy-making.

While the research question is well-stated, the article could better highlight how it addresses gaps in existing studies, particularly in the "social integration and risky behaviors" context.

The description of how NVivo12 software was employed in data analysis is minimal. Consider adding details about coding processes or analytic strategies to enhance transparency.

The phrase "family support is highlighted as a crucial factor..." appears multiple times with slight variations. Consolidating these into a single, well-structured paragraph would improve readability.

While the article references the Grounded Theory paradigm, it does not explain the rationale for choosing this framework. Adding this would provide context for its suitability to the research.

The limitations section does not explicitly address potential biases introduced by the researcher's dual role as interviewer and data analyst. Reflecting on this would strengthen credibility.
